GENERAL MEETING

1 Minute of Meeting Held on 28 May 2007

The minute of the meeting held on 28 May 2007 was agreed as accurate.

2 Matters Arising

Kirriemuir Twinning Association

IP gave a brief report to the Partnership on a Kirriemuir Twinning Association event which had taken place earlier in the year.

The Kirriemuir Twinning Association had organised a visit for pupils and teachers from the French twin town of Volvic and the surrounding area, to spend a week in the Kirriemuir area.

The visit also included a programme of events from a ceilidh to a number of sight-seeing tours.

AN thanked IP for his report and congratulated the group on a successful event.

3 Old Southmuir Primary School - Craig Clement, Angus Council

Craig Clement - Education Department, Angus Council - gave an update to the Partnership on the old Southmuir Primary School site and Angus Council's plans to improve and extend facilities at Webster's High School.

CC advised that it is intended by Angus Council that the insurance receipt from

the former Southmuir Primary School is used to provide upgraded facilities and additional classrooms and extra accommodation, and that there is an opportunity to incorporate the old school site into the current Southmuir/Webster's High campus.

Angus Council also plan to work in partnership with the Kirriemuir Community Sports Association in order to improve external facilities at the school. The Kirriemuir Community Sports Association aims to provide an all-weather pitch on the playing fields of Webster's High School, and as Sportscotland has indicated support in principle for the project, they may, subject to a successful grant application, contribute towards funding.

CC circulated a plan of the site for the group to have a look at and discussion followed.

AT asked CC if the proposed plans would include space for the community to use. CC advised that the plans may include additional rooms which could be used by the community but that this is something which would have to be looked at in more detail as it would need to be managed in some way.

AN suggested that the new space could be managed by leisure staff.

SF asked if and when there would be an opportunity for consultation about the plans with the wider community. CC advised that consultation with both the school and the wider community is to take place shortly and that the Partnership will be included in this process.

AN invited CC to attend the next Partnership meeting to give an update on the plans. CC agreed to do this.

AN thanked CC for attending the meeting.
